About West Midlands Adult Learning Awards

The West Midlands Adult Learning Awards seek to recognise and celebrate the achievements of local learners, businesses, providers and wider partners. Through these awards, we are looking to:

- Raise the profile of adult learning across the region
- Engage more residents, businesses and wider stakeholders in adult learning
- Capture and celebrate good practice in adult learning across the region
- Showcase the full range of economic and social benefits of adult learning
- Demonstrate the impact of skills devolution, enabling us to make the case for further devolution.

Award winners are selected for a range of awards across four nomination categories:

- Individual learner
- Tutor
- Employer
- Learning provision (includes learning providers and partnerships)

Why nominate?

By nominating an individual learner, provider, tutor or employer you can celebrate their successes. Providers and employers can showcase their work and use it for both recruitment and reputation purposes. Individuals could showcase it on their CVs or LinkedIn profiles to highlight their commitment to professional development and learning.

Selection of award winners - key dates

- All nominations **must** be submitted by Friday 24 February 2023 at 12.00 noon GMT.
- Winners will be selected by mid-March 2023.
- Winners and their nominators will be notified by 31 March 2023.
- Nominators of non-winners will be sent a certificate of achievement to present to their nominee.
- Winners will be announced in May 2023 (date tbc).

The deadline for nominations is final and there will be no extensions provided. If you haven't heard from us by the middle of April 2023, please assume that your nominee has not been selected as an award winner on this occasion. The decisions of the selection panel is final.

Guidance notes and eligibility criteria

We're looking for provision that has had a transformational impact on learners. The provision should be funded through the Adult Education Budget in the West Midlands, and can also include Construction Gateway, Bootcamps and Free Courses for Jobs. Specifically, this includes supporting learners to increase their skills, ability and confidence including providing routes to employment or other learning opportunities which may not have been possible previously. We want to recognise that learning doesn't just stay in the classroom. We are also looking for provision that motivates people to take up learning, especially those who may lack the confidence to do so.

Outstanding learning provision will have:

- Provided families or communities with opportunities to learn together.
- Provided clear learning progression routes or contributed to motivational learning journeys.
- Demonstrated how the learning has helped improve/change learners' lives and the lives of their families, friends, colleagues or the community.
- Supported individuals to improve their skills for employability and professional development, or to progress in their career or retrain for new job roles or new responsibilities within existing job roles.
- Used outstanding creativity and innovation or have worked in partnership to significantly benefit those participating in the project.
- Demonstrated success in engaging those families and communities who are furthest away from learning and employment, and which shows clear individual and communitywide benefits.
- Illustrated the transformational power of learning in relation to learning as a family, in a community environment or in relation to work.
- Provided evidence of how the learning has made a difference to learners' experiences, opening up other opportunities and impacting on those around them.
- Made a very strong case for devolution of learning and skills funding.

Innovative Delivery award

The winner of this award needs to showcase outstanding creativity and innovation in the delivery of provision funded through the Adult Education Budget in the West Midlands, including Construction Gateway, Bootcamps and Free Courses for Jobs. They should be able to demonstrate successful and impactful outcomes for learners and their organisations, as well as impacts on wider society and economy.

Successful Partnership award

We are looking for funded organisations that have either worked with, or are currently working with, a partner to successfully deliver inclusive, impactful and demonstrably effective provision. We are particularly interested in cross-sector partnerships, for example with health or employment support services. The partnership needs to benefit both organisations, demonstrate clear outcomes and should be inspiring and be easily replicated by other organisations. The provision should be funded through the Adult Education Budget in the West Midlands, which can include Construction Gateway, Bootcamps and Free Courses for Jobs.

Engaging Adults in Learning award

This award is for outstanding commitment to helping individuals in the West Midlands to gain the skills and support that they need for life, work or to access good work. The winner should be able to provide evidence of how they have effectively engaged adults furthest away from the provision, and how the learning has made a difference to learners' experiences, opening up other opportunities and impacting those around them.

Community Learning Provider of the Year award

This award is for providers delivering outstanding Community Learning provision funded through the Adult Education Budget. The winner should be able to demonstrate how they effectively support adults who are taking their first step into learning or who are returning to learning after many years. Nominees should outline the impact they have made to the local community, for example increase in civic engagement, increase of volunteer pool in the area, increase participation in local communities/from groups of learners who are very hard to reach and are underrepresented in adult learning.

Learning provider eligibility criteria

- Nominations are open to learning provision based in the West Midlands where at least two months of the learning activity has taken place between 1 January 2022 and 1 February 2023.
- The provision must be funded through the Adult Education Budget, and can also include Construction Gateway, Bootcamps and Free Courses for Jobs.
- A learner's statement must be included in the nomination of the provision.
- There is no limit to the number of nominations that one nominator can make. However, nominations for one nominee from multiple nominators are not accepted.
- Nominations for provision that has been nominated in previous years, or provision that has won awards as part of other award initiatives, will be accepted.
- Nominations must be authorised by a relevant senior manager before submission.

How to submit a nomination

Please read through the following guidance carefully.

- The awards nominations process is **online**.
- Nominations should be submitted online by the **nominator**.
- There are four different online nomination forms for:

- o Individual learners
- o Tutors
- Learning provision
- o Employers
- The online nomination form needs to be completed in one sitting. You cannot save a partially completed nomination form and return to it later. Therefore, we strongly advise you to prepare and draft your nomination using this document in advance.
- It is possible to submit multiple nominations. Once one nomination has been completed and submitted online, you will be able to begin the form again to start a new nomination.
- Nominations for learning provisions will need to include a written statement from at least one learner. It is the nominator's responsibility to explain the process to the learner and obtain the relevant written statement for inclusion in the nomination.

Preparing and drafting nominations

The questions that form the project nomination form have been provided within this document to help you prepare and draft your nomination. We recommend that you use this document to do this for the following reasons:

- It will enable you to review all questions on the nomination form before completing any answers. The online nomination form requires you to complete one section before you can move on to view the next.
- You will be able to work on your nomination form without being connected to the internet. An internet connection is required to work on the online nomination form.
- Should you encounter any technical issues with the online form, you will still have a saved copy of your work in this Word document.
- To keep a copy of your final nomination for your own records. Once your nomination has been submitted, you will no longer be able to access it online.

When you are happy with your nomination, complete the online form by copying answers from each box in your pre-prepared Word version into the relevant boxes of the online nomination form.

Please note that we cannot accept nomination forms that are submitted using this document. This document has been provided to help you to draft your nomination only.
