#### 1.0 METHODOLOGY

In order to comply with the requirements of British Standard 7958, Closed Circuit Television (CCTV) Management and Operation — Code of Practice and the recommendations contained in the Information Commissioners CCTV Code of Practice published in October 2014 and Surveillance Camera Code of Practice. West Midlands Combined Authority commissioned Plass Solutions Ltd to conduct an evaluation of the Rail Stations and car park CCTV systems that have been monitored by the CCTV Control Room for the twelve months under review.

Whilst the Information Commissioners CCTV Code of Practice and the Surveillance Camera Code of Practice mention that a review should be undertaken that assesses the effectiveness of the system, British Standards are specific in the criteria required to be covered by such an evaluation. However, the afore-mentioned Codes of Practice agree that the results of the evaluation should be publicly available.

The topics required to be covered by the British Standard are as follows:

- a) a description of the scheme and the geographical area(s) of operation the schemes policy statement
- b) the purpose and scope of the scheme
- c) any changes to the operation or management of the CCTV scheme
- d) any changes that have been made to the policy
- e) any proposals to expand or reduce the operation of the scheme
- f) the aims and objectives for the next 12 months.

The British Standard also requires the following information to be included within the evaluation:

- a) the number of incidents recorded by the scheme
- b) the number of incidents reported to the police and where appropriate other bodies
- c) an assessment of the CCTV scheme's impact on crime levels and types of crime in the area covered by the scheme.

As the West Midlands Combined Authority CCTV Control Room is accredited to the above mentioned British Standard and the Surveillance Camera Commissioner's Code of Practice, the following evaluation will focus on the content of that Standard and the Code of Practice as outlined above.

#### 2.0 INTRODUCTION

By 1992, crimes affecting the travelling public on some railway stations and car parks in the West Midlands had reached substantial levels. The seriousness and regularity of these incidents began to have an impact on the perception of crime on the railway network and in turn this was beginning to undermine the confidence of passengers.

In the early part of 1992, as a result of these high levels of crime, a working party commenced a feasibility study into the installation of Closed Circuit Television into the most seriously affected rail stations and car parks. The decisions were based upon crime analysis supplied by the British Transport Police and consultations with Police, passengers and rail staff. The Discussion/Strategy document was completed in October 1992 and recommended the installation of CCTV on eleven of the worst affected rail stations and car parks. Installation work commenced in March 1993. The original objectives were to reduce crime by 40% to 50% and raise the perception of security on the chosen stations.

In 1994, the first full year following installation of CCTV on the eleven stations and their car parks crime decreased by 84%. This trend continued but with generally smaller decreases. Three years after installation a survey amongst rail users on the stations with CCTV showed that 76% felt safer since cameras had been installed.

It became apparent that in order to initiate the appropriate response to incidents captured by the CCTV systems, it was essential to provide constant and effective monitoring. This would assist in creating a pro-active CCTV system as opposed to the passive application the system had become. The decision was therefore taken to provide constant monitoring of the CCTV systems within a dedicated environment and on the 22<sup>nd</sup> January 2001 the Network Safety and Security Centre was officially opened.

The success of the initial CCTV schemes in reducing crime and increasing passenger confidence in safety and security, whilst recognising the potential for displacement of crime on to other rail stations, prompted the development of a strategic approach to further expansion of this technology throughout both rail and bus stations which are the responsibility of West Midlands Combined Authority.

In order to provide a more effective service a dedicated CCTV control room was constructed and monitoring of all CCTV systems commenced in May 2011. This has enabled state of the art technology to be introduced into a specially designed environment. At the present time there are a total of 53 rail stations and car parks monitored in the West Midlands Combined Authority Control Room.

#### 3.0 POLICY STATEMENT AND SCHEME DESCRIPTION

### 3.1 Closed Circuit Television

The scheme initially comprises of cameras located in specific external and internal locations with control, monitoring and recording facilities at a dedicated control room. A problem orientated process was utilised to assess the appropriateness of CCTV in the area subject of this evaluation. The cameras have therefore been sited to capture images that are relevant to the purposes for which the scheme has been established. The purposes of the CCTV scheme are outlined later in this report. As previously mentioned the CCTV Control Room has now been moved from the previous location into a purpose design facility.

### 3.2 Ownership

The scheme is owned by West Midlands Combined Authority who is responsible for the management, administration and security of the system. West Midlands Combined Authority and its partners will ensure the protection of individuals and the public by complying with the Codes of Practice.

### 3.3 Policy Statement

To promote public confidence by developing a safe and secure environment for the benefit of those employed, visiting or using the facilities provided by West Midlands Combined Authority.

To inspire public confidence by ensuring that all public area Closed Circuit Television (CCTV) systems which are linked to the West Midlands Combined Authority CCTV Control Room are operated in a manner that will secure their consistent effectiveness and preserve the civil liberty of law abiding citizens at all times.

#### 4.0 THE PURPOSE AND SCOPE OF THE SCHEME

### 4.1 Purposes of the scheme

The following are the objectives for which West Midlands Combined Authority CCTV system was established:

- a) assist in the prevention and detection of offences
- b) reduce both the real and perceived level of crime
- c) reduce the fear of crime
- d) improve confidence in the rule of law
- e) assist in the apprehension and prosecution of offenders.
- f) gather evidence by a fair and accountable method
- g) create a safer community, improving the quality of life for all by:
  - > reducing car crime
  - > monitoring public disorder
  - > monitoring the movement of people in emergency situations, e.g evacuation
  - > providing assistance in civil claims
  - > providing assistance with issues relating to public safety and health

### 4.2 Scope of the scheme

The cameras have been sited to capture images which are relevant to the purpose for which the schemes has been established.

The schemes will be operated fairly, within the applicable law and only for the purposes for which it is established or which are subsequently agreed in accordance with the Code of Practice.

Operators are aware of the purpose(s) for which the schemes have been established and that the CCTV equipment is only used to achieve the identified purposes.

The schemes will be operated with due regard for the privacy of the individual.

Before cameras are placed in residential areas the residents in that area will be consulted concerning the proposed system. The results of the consultation will be taken into account. The public interest in the operation of the schemes will be recognised by ensuring the security and integrity of operational procedures.

The systems will only be operated by trained and authorised personnel.

An evaluation of the schemes is carried out annually and this will be available to the public at specified locations.

West Midlands Combined Authority and partners support the individual's right to privacy and will insist that all agencies involved in the provision and use of Public CCTV systems connected to the West Midlands Combined Authority CCTV Control Room accept this fundamental principle as being paramount.

The schemes aim to provide surveillance of the public areas in order to fulfil the purposes of the schemes. The area protected by CCTV is indicated by the presence of signs. The signs are placed so that the public are aware that they are entering a zone which is covered by surveillance equipment. The signs state the organisation responsible for the schemes, the purposes of the schemes and a contact telephone number. Data will not be held for longer than necessary and disposal of information will be regulated.

The schemes are registered with the Information Commissioner. The registration number is Z5897556. The schemes will be managed in accordance with the principles of the Data Protection Act 2018, Human Rights Act 1998 and all other relevant legislation

Reviews of Data Protection and Legal requirements are undertaken annually.

#### 4.3 Personnel

All personnel involved with the monitoring of CCTV have or are in the process of being security screened in accordance with British Standards.

#### 4.4 Training

All employees engaged in the monitoring and operation of CCTV have or are in the process of receiving training to the standards required by the Private Security Industry Act 2001. As a further requirement of the above Act all operators will be licensed by the Security Industry Authority.

### 4.5 Operation of the scheme

The system is operated in accordance with a recognized Code of Practice and Procedural Manual.

#### 4.6 Audit

As mentioned in the introduction to this report the scheme is required to be independently monitored this includes a review of the scheme's operation and working practices.

An audit has been undertaken on 4<sup>th</sup> October 2021 prior to this evaluation report which considered the following:

a) the level of attainment of objectives and procedures.

The level of attainment of objectives is covered in the main evaluation. The statistics relate to the 2021 period. Procedures are governed by the Code of Practice and Procedural Manual. These were reviewed and comply with relevant processes and legislation in particular the Data Protection Act 2018 and Human Rights Act 1998.

b) random audits of the data log and the release of information

All administrative documentation, which incorporate the release of information and incident reports in connection with this scheme were examined and all appear to be completed in accordance with the Procedural Manual.

c) the review policy

The review policy is outlined within the Code of Practice. Procedures are reviewed on an ongoing basis in order to comply with procedures and legislation.

d) standard of costs for the release or viewing of material

The Information Commissioner confirms the cost should be free of charge. However, West Midlands Combined Authority may charge reasonable fees when responding to manifestly unfounded or excessive requests. There were no Subject Access Requests received and processed in 2021.

e) Legislation

At the time of the above audit all legislative requirements appear compliant.

### 5.0 CHANGES IN OPERATION, MANAGEMENT OR POLICY

As reflected in the Code of Practice, any major changes to the Code of Practice take place only after consultation with the relevant management group and upon agreement of the organisations with a participatory role in the operation of the system.

- **5.1** Major changes to the code are defined as changes which affect its fundamental principles and shall be deemed to include:
  - additions and omissions of cameras to the system matters which have privacy
  - implications
  - additions to permitted uses criteria e.g. purposes of the scheme
  - changes in the right of access to personal data, except statutory requirements
  - significant legal implications.
- 5.2 Minor changes to this Code of Practice are defined as operational and procedural matters which do not affect the fundamental principles and purposes; these include:
  - additions and omissions of contractors
  - additional clarifications, explanations and corrections to the existing code
  - additions to the code of practice in order to conform to the requirements of
  - any statutory Acts and changes in criminal legislation.

A minor change may be agreed between the manager and the owner of the system.

There have been amendments to the Code of practice or procedures during the period under evaluation and these are mainly updates to legislation and guidance.

### 6.0 PROPOSALS FOR THE SCHEMES INCLUDING AIMS AND OBJECTIVES

West Midlands Combined Authority CCTV Control Room utilises the latest technology in Closed Circuit Television. This is seen as being beneficial to all those who visit, reside and work in the area.

The aims and objectives remain the same and these are the prevention and detection of crime, to reduce the fear of crime and make the area a safe environment.

#### 7.0 STATISTICAL ANALYSIS AND EVALUATION

In order to achieve meaningful evaluation, the CCTV scheme must be assessed against specific performance indicators which are relevant to the objectives of the scheme. This can be achieved by utilising baskets of indicators which are divided into the categories of Contextual, Key and Support Indicators.

#### 7.1 Contextual Indicators

Contextual Indicators relate to the circumstances or background surrounding the particular initiative. In this case the purposes of the CCTV are mainly to prevent and detect crime. Indicators will include both British Crime Statistics and Police Recorded statistics for this type of crime.

#### **7.2** Key Indicators

Key Indicators are closely related to the actual objectives of the particular initiative and attempt to measures its effect. This will include the total crime for the police area.

### **7.3** Support Indicators

Support Indicators are used to refute or verify the key indicators. The measurements will include the number of images seized by police which contain evidential value.

#### 7.4 EVALUATION

#### 7.4.1 British Crime Survey

The responsibility for the publication of crime statistics transferred from the Home Office to Office of National Statistics (ONS) in April 2012, with the year starting on 1st July and finishing on 30th June. The following information has been taken from the ONS website.

Patterns of crime in the year ending June 2021 have been significantly affected by the coronavirus (COVID-19) pandemic and government instructions to limit social contact. Periods of national lockdown have seen decreases in the incidence of many types of crime. This has generally been followed by a return towards previous incidence levels once lockdowns ended.

.....

Crime Survey for England and Wales (CSEW) estimates provide the best indicator of long-term trends. Estimates from the Telephone-operated Crime Survey for England and Wales (TCSEW) for the year ending June 2021 compared with the pre-COVID year ending June 2019 show:

- A 12% increase in total crime, driven by a 43% increase in fraud and computer misuse.
- A 14% decrease in total crime excluding fraud and computer misuse, largely driven by an 18% decrease in theft offences.
- Little change in the total number of incidents of violence but a 27% decrease in the number of victims of violent crime, largely driven by falls in violence where the offender was a stranger, in part reflecting the closure of the night-time economy for several months of the year.

Fraud and computer misuse offences do not follow the lockdown-related pattern of reduced victimisation. Increases in these offences more than offset the reductions seen for other types of crime. Crime survey estimates for the year ending June 2021 compared with the year ending June 2019 show:

- A 32% increase in fraud incidents, largely driven by substantial increases in both "consumer and retail fraud" and "advance fee fraud".
- An 85% increase in computer misuse incidents, driven entirely by an increase in "unauthorised access to personal information, including hacking".

Police recorded crime data show a similar pattern to the crime survey, with overall reductions in the reporting and recording of many crime types during periods of lockdown. These data give more insight into lower-volume but higher-harm crimes that the survey does not cover or does not capture well. Compared with the year ending June 2020 they show:

- An 11% decrease in the number of homicides, to 627 offences (and a 5% fall excluding the Grays lorry incident).
- A 6% decrease in the number of police recorded offences involving firearms.
- An 8% decrease in offences involving knives or sharp instruments (knife-enabled crime).

Sexual offences, as recorded by the police, were also lower during periods of lockdown, but to a lesser extent during the winter 2020 to 2021 lockdown than during the spring 2020 lockdown. The number of sexual offences reached its highest ever quarterly level between April and June 2021. Caution is needed when interpreting the level of police recorded sexual offences. Recent figures may reflect a number of factors including the impact of high-profile cases and campaigns on victims' willingness to report incidents. Police recorded crime data for the year ending June 2021 show:

- The highest number of rape offences (61,158) recorded in a 12-month period, driven by the highest quarterly figure (17,285) between April and June 2021.
- The second highest number of sexual offences (164,763) recorded in a 12-month period, driven by the highest quarterly figure (48,553) between April and June 2021.

#### 7.4.2 West Midlands Police crime and offence statistics.

As previously mentioned, contextual performance indicators are closely related to the background and environment of the particular initiative, it is therefore advantageous to examine the context in which the cameras operate. This will include the total crime for the police area. There is an argument that the number of recorded offences would be reflected in the levels of incidents created by the CCTV operators.

During 2017 the recorded crime has increased by 9.1%. There was an increase in Violence (+12.8%), Criminal Damage/Arson (+5.9%), Shoplifting (+2.2%), Other Theft (+20.3%), Other Crime (+8.4%), Bike Theft (+2.6%), Public Order (+15.7%), Vehicle (+20.8%), Weapons (+6.5%), Burglary (+6.6%) and Robbery (+22.9%). Decreases were recorded in Anti-Social Behaviour (-4%), Theft from a Person (-4.1%) and Drugs (-21.2%).

During 2018 the recorded crime has increased by 4%. There was an increase in Violence (+27%), Other Crime (+15%), Drugs (+9%), Public Order (+27%), Vehicle (+3%), Theft from a Person (+11%), Weapons (+28%), Burglary (+8%), Other Theft (+6%) and Robbery (+12%). Decreases were recorded in Anti-Social Behaviour (-22%), Criminal Damage/Arson (-3%), Bike Theft (-10%), and Shoplifting (-5%).

During 2019 the recorded crime has decreased by -0.2%. There was an increase in Weapons (+28%), Drugs (+25%), Violence (+22%), Public Order (+19%), Other Crime (+17%) and Robbery (+8%). Decreases were recorded in Bike Theft (-18%), Anti-Social Behaviour (-17%), Burglary (-15%), Other Theft (-15%), Shoplifting (-11%), Vehicle (-11%), Theft from a Person (-4%) and Criminal Damage/Arson (-2%).

During 2020 the recorded crime has increased by 7.5%. There was an increase in Public Order (+41%), Anti-Social Behaviour (+40%), Violence (+25%), Other Crime (+25%), Weapons (+8%) and Drugs (+3%). Decreases were recorded in Theft from a Person (-33%), Shoplifting (-30%), Burglary (-22%), Robbery (-22%), Other Theft (-21%), Vehicle (-19%), Criminal Damage/Arson (-14%) and Bike Theft (-9%).

The recorded crime data for 2021 could not be fully obtained. West Midlands Police have made a statement on their website "Due to recent major system changes, the force is unable to provide Crime and Stop and Search data from April 2021 onwards. The force aims to rectify this issue as soon as possible in the coming months." The data below, therefore, is for a period of 5 months from January to May 2021.

The recorded crime has increased by 22%. There was an increase in Public Order (+66%), Weapons (+61%), Violence (+49%), Criminal Damage/Arson (+48%), Other Crime (+41%), Drugs (+24%), Other Theft (+7%), Bike Theft (+4%) and Robbery (+1%). Decreases were recorded in Burglary (-19%), Anti-Social Behaviour (-16%), Vehicle (-5%), Theft from a Person (-3%) and Shoplifting (-3%).

### 7.4.3 Analysis of Recorded Crime Levels – Rail stations and Car Parks

During 2020, there were 515 offences recorded in the areas covered by the CCTV systems. In 2021, the number of offences has increased to 833 occurrences. Moor Street was the main locations for offences with 32 incidents each. The category of offences for each location can be found in Appendix 'A'. Without a more detailed analysis it is difficult to establish if the CCTV has had positive effect and it will be necessary to monitor and evaluate the system over the next 12 months.

#### 7.5 Support Indicators

#### 7.5.1 Incident Reports - 2017, 2018, 2019, 2020 and 2021

The success of a CCTV scheme relies, to a considerable extent, on the pro-active use of the system by the operators. This sophisticated technology is primarily a passive devise and without human interaction it relies on an incident occurring within its field of view, this is the case even when on automatically programmed patrols.

It is necessary therefore to ascertain if the system is being used to its full potential by those operating the cameras and one method of establishing this is to analyse the Incident Reports. Details of incidents dealt with by Operators are passed to the relevant authority. Incidents are not always responded to immediately by the Police, but are monitored and recorded by Operators on their behalf.

### 7.5.2 Analysis of Recorded Incidents

It is necessary to be able to justify the existence of each camera which forms part of the CCTV scheme and the only measurement is when it has been used during an incident.

It should be explained that when monitoring of an incident, it is normal practice to use a number of cameras and therefore the analysis will have no resemblance to the actual number of incidents. However, it will provide an indication of the usefulness of each camera to the overall system when dealing with incidents.

During 2017 the number of uses increased to 5045 and this averaged out at 6 usages for each camera. During 2018 the number of uses decreased to 4206 and this averaged out at 2 usages for each camera. During 2019 the number of uses decreased to 735 and this averages out at 2 usages for each camera. During 2020 the number of uses increased to 760 and this averaged out at 2 usages for each camera. In 2021 the number of uses increased significantly to 1637 and this averages out at 1 usage for each camera. An analysis of the number of recorded incidents can be found in Appendix 'C'.

Using a formula employed by a number of Local Authorities, all cameras with less than half the average number of usages would be regarded as being 'at risk' of further consideration. Using a similar formula as described, during 2017 there were 386 cameras below half the average of 3 usages. During 2018 there were 378 cameras below half the average of 2 usages. During 2019 there were 945 cameras below half the average of 2 usages. During 2020 there were 971 cameras below half the average of 2 usages. In 2021 there were 140 cameras below half the average of 1 usage and these should be further investigated as to their continued justification. However, most of these cameras have specific and/or unique operational requirements, which include the security of staff and people using the station facilities.

Two of the primary purposes for the installation of CCTV into the locations under review are the prevention of offences and the protection of life and property. The low incident rate would tend to suggest that the individual CCTV systems are achieving the required outcomes. However, the reality is more complex, as the systems may form part of a package of crime reduction initiatives and techniques. Also, under reporting may contribute to the assumption that an initiative is achieving the required results.

### 7.5.3 Viewing and Seizure of evidence

The viewing and subsequent copying/seizure of recorded images can act as an indicator to support or refute the effectiveness of the scheme in obtaining meaningful evidence.

------

However, it is difficult, if not impossible to ascertain from police records whether the images viewed have been used as evidence to obtain a conviction at court, assisted in any other clearance process or been used for intelligence purposes.

During 2017, there were 471 reviews conducted by the police and this was an increase of 178 over the previous period. 413 DVD/CDs and 7 stills were issued to the Police. During 2018, there were 489 reviews conducted by the police and this is an increase of 18 over the previous period. 366 DVD/CDs, 33 USBs and 90 stills were issued to the Police. During 2019, there were 414 reviews conducted by the police and this is a decrease of 75 over the previous period. 346 DVD/CDs, 8 USBs and 60 stills were issued to the Police. During 2020, there were 242 reviews conducted by the police and this is a decrease of 172 over the previous period. 201 DVD/CDs/USBs and 78 stills were issued to the Police and third parties.

The viewing and subsequent copying/seizure of recorded images can act as an indicator to support or refute the effectiveness of the scheme in obtaining meaningful evidence. The following requests were issued:

### 7.5.5 Privacy Impact Assessments

During 2021 there have been no additional cameras installed in the locations subject of this evaluation and therefore no Privacy Impact Assessments undertaken.

#### 8.0 CONCLUSION AND RECOMMENDATIONS

#### 8.1 Introduction

This camera evaluation focuses on the 1242 public space Closed Circuit Television surveillance cameras installed on the rail stations and car parks monitored by West Midlands Combined Authority in their CCTV Control Room facility.

#### 8.2 Recorded Crime

During 2017 the number offences decreased to 600 occurrences. During 2018 the number offences increased to 788 occurrences. During 2019 the number offences decreased to 662 occurrences. During 2020 the number offences decreased to 515 occurrences. In 2021 the number offences have increased to 833 occurrences. Moor Street was the main locations for offences. The category of offences for each location can be found in Appendix 'A'.

### 8.3 Recorded Incidents by CCTV Operators

During 2017 there were 5045 incidents recorded by the CCTV operators, this decreased to 4206 incidents in 2018. In 2019 it decreased again to 735 but increased slightly in 2020 to 760. In 2021 the number decreased to 482 incidents recorded by the CCTV operators. There is now a total of 1242 cameras installed on the rail stations and car parks. The average number of incidents per camera during 2017 was 6. In 2018 it decreased to 4 incidents per camera with a further decrease in 2019 to 2 incidents per camera. In 2020, it remained 2 incidents per camera. In 2021, it decreased to 1 incident per camera.

The type of incidents can be found in Appendix 'B' and the number of camera uses for each camera can be found in Appendix 'C'.

### 8.4 Police Reviews of footage

Another important indicator is the number of reviews conducted by the police. In 2018, there were 489 reviews conducted by the police and this was an increase of 18 over the previous period. 366 DVD/CDs, 33 USBs and 90 stills were issued to the Police.

During 2019, there were 414 reviews conducted by the police and this is a decrease of 75 over the previous period. 346 DVD/CDs, 8 USBs and 60 stills were issued to the Police.

------

In addition to the Police, there were 47 DVDs, no USBs and 9 Stills issued to third party requests. During 2020, there were 279 reviews conducted by the police and this is a decrease of 135 over the previous period. 201 DVD/CDs/USBs and 78 stills were issued to the Police and third parties. In 2021, there were 100 reviews conducted by the police and this is a decrease of 179 over the previous period. 66 DVD/CDs/USBs and 34 stills were issued to the Police and 15 DVD/CD/USBs and no stills to third parties.

Generally, it would appear to indicate that the police and third parties are finding the CCTV systems useful and this is a positive support indicator.

#### 8.5 Future Evaluations

It has not been possible to provide an analysis which justifies continued use of each camera, due to the problems of extracting the relevant data from the management system. This is an area which needs to be addressed in order for meaningful evaluation of the system to be undertaken.

The Information Commissioners CCTV Code of Practice makes the following requirement;

"If you are already using a surveillance system, you should regularly evaluate whether it is necessary and proportionate to continue to use it"

"You should review regularly whether the use of CCTV continues to be justified. It is necessary to renew your notification with the ICO annually, so this would be an appropriate time to consider the ongoing use of such systems."

...there should be a periodic review, at least annually of the system's effectiveness to ensure that it is still doing what it was intended to do. If it does not achieve its purpose, it should be stopped or modified."

### **Information Commissioners Code of Practice 2014**

The purposes and scope of the systems are detailed in Section four of this report and these include the prevention and detection of offences. Whilst it is not possible to make an assumption that the CCTV system is actually preventing offences, it is a component part of the preventative package.

To remove or modify the use of the CCTV system may also detract from a further identified purpose, this being to reduce the fear of crime. It is therefore recommended that at present the system is effective in achieving its purpose, however, there is no current research available which would indicate the public or employees' perceptions and this is an area which could provide valuable information in future evaluations.

\_\_\_\_\_\_

It is a recommendation that the West Midlands Combined Authority Rail CCTV systems continue to be evaluated on an annual basis. This will ensure future compliance with the British Standard, which is assessed each year, it will also provide compliance with legislation and ensure continuous measurement of fluctuations and monitoring for any emergence of life cycles, which could cause a decline in the initiative. CCTV evaluations are also required for compliance to the Surveillance Camera Code of Practice 2013.
