

Forum logistics reminder

Format

- Other specific roles and responsibilities to be discussed as the Forum evolves e.g. co-convenor roles

Tree & Hedge planting discussions

Discussions in breakout rooms;

- Difficulty surrounding land, access and regulations scope for a programme to bring organisations together to submit planting programme.
 - WMCA Environment Team have submitted a bid into the Woodland Trusts' Emergency
 Tree Fund to create a West Midlands Forest Partnership. The Partnership would aim to
 create a regional focus to tree and hedge planting and to complete an i-tree
 assessment of current tree stock, similar to the assessment in the Black Country. We
 should know the outcome soon and would look to increase team capacity to lead on
 this work.
- Tools libraries for the community to borrow tools to plant trees
 - The WMCA Environment Team will have a conversation with the Active Wellbeing Society who have several 'Share Shacks' in Birmingham and North Solihull. The WMCA will look into including community reuse hub as part of our circular economy work, more information on our circular economy routemap can be found here.
- Issue with tree nurseries keeping up with supply and need to set up local tree nurseries to be more self sufficient
 - In the WMCA Natural Environment Plan we have committed to creating a West Midlands tree nursery and will work with partners to progress this. More information on our Natural Environment Plan can be found on our website here.
- How can we work with bigger landowners, who can make a bigger difference than any small group could?
 - In the WMCA Natural Environment Plan we have committed to hosting a regional landowners summit to promote collaboration and bring forward land for trees and other biodiversity projects.

Areas for the Forum to progress;

- Funding available for tree planting but more support needed for street trees and for ongoing management
- Emphasis needs to be on protecting existing trees, especially with new developments and protecting against vandalism
- Need targets and incentives for natural regeneration
- Knowledge sharing and capacity building for community groups, councils and the general public on best practice for improving biodiversity, planting street trees, growing trees from seed, restoration of hedgerows and knowledge of existing habitats

Financing Sustainability Transitions: In Search of a New, Civic-led Orthodoxy

Finance at the Climate Crossroads

Since the signing of the <u>UNFCCC's Paris Agreement</u> in 2015, \$3.8 trillion has been invested in fossil fuels, and much of the money set aside to 'build back better' will not address climate change. The role of finance in both the causes of climate breakdown and how we pull our societies back from the brink is a crucial and hot topic that many individur at low-silver carbon, climate-resilient, just, and inclusive ruture are grappling with.

We think there are four key ingredients.

01 Hyper-local engagement and ownership

Addressing low levels of

trust and weak

mobilisation of residents

to act / lead their local

transitions through

street-scale 'civic

associations' with

collective imagining and

shared decision-making

mechanisms.

02 Neighbourhood Retrofit agency

Addressing issues of credibility, compliance & capitalisation through neighbourhood-scale 'transition entities' with asset ownership and service delivery capacity.

03 City region scale spiral

Addressing historic power imbalances through city-scale capital funds designed to spiral investment capacity downwards to build community wealth and local economic empowerment.

04 National-scale open infrastructure

Addressing scaling barriers through explicit proliferation infrastructure including legal, procurement, democratic templates & protocols as well as platforms.

/ Democratising Knowledge



/ Unlocking + Cultivating Imaginations



Organising as interconnected ecosystems, with partners, across challenges, opportunities, outcomes, portfolios, rather than isolated discrete projects and solutions.














Designed for community living


The house type brings together many of the lessons we've learned about how to build homes that work. It is compact, flexible and economical — but at the same time the design is bright, generous and designed with user needs in mind, even down to small details.



Test location. Within the larger site, Architecture 00 have tested a co-living scheme of 15 units. The aspiration being to layout a logic for the first dwellings that could then be replicated across the site linking the communal facilities into a new 'community cluster'. Taking advantage of the existing retaining walls, the design seeks to create unique communal facilities that float over the canal and create key visual links for residents and security to the canal route.
